That the Members of the Council condemn all persons and organisations who engage in any activity or perform any act aimed at the destruction or limitation of any of the rights and freedoms set forth in the European Convention on Human Rights and Fundamental Freedoms

## 2. NOTICE OF MOTION - COUNCILLOR HATCH

That the Members of this Council do not support the attainment of any political end or object by means of violence, unlawful activity or any act of terrorism, whether directed against persons or property.

## 3. NOTICE OF MOTION - ALDERMAN CALVERT

That the Members of the Council, being apprehensive concerning the personal safety of Members of the Council, Employees of the Council Guests of the Council, Associates of Council Members and the security of Council and other property, hereby resolve that no Member be entitled to attend or participate in any Meeting or Event of the Council, or any of its Committees, or to have access, in his/her capacity as a Councillor, to any Council Officer, Records or Information until such time as a Declaration and Acknowledgement in the form appended hereto, duly signed by that Member, is lodged with the Clerk & Chief Executive.

## NOTICE OF MOTION - ALDERMAN S GARDINER

In the event of any Member who has not signed the Declaration and acknowledgement attending, or attempting to attend, any Meeting or Event of the Council or any of its Committees, the Mayor or the person presiding shall require him/her to leave forthwith.

The following is the text of the statement of declaration as proposed by Motions 3 & 4.

DECLARATION AND ACKNOWLEDGEMENT

declare and acknowledge that I will not use my

position as a Councillor, whether at any meeting of the Council or elsewhere, for the purposes of advancing any of the aims or objects of any organisation which:-

- (a) Engages in violence, unlawful acts or acts of terrorism with a view to obtaining a political end.
- (b) Has as its avowed aim or ultimate purpose the subversion of the State and the present Constitution by means of violence, unlawful activities or acts of terrorism whether directed against persons or property.

I declare and acknowledge that I will do my utmost and use my best endeavours to prevent any proceedings of the Council being used by any person to gain or lend support or aid to any organisation which engages in violence, unlawful activities or acts of terrorism with a view to obtaining a political end or subverting the State or the present Constitution.

I declare and acknowledge that I will not communicate any information or material concerning Council business, Council employees or personnel, or Council property which may be of assistance to any unlawful organisation or any organisation which does not reject violence, unlawful activities or acts of terrorism as a means of obtaining political aims. The following statement was delivered to the meeting of Craigavon Council on July 19th. by Councillors Breen and French. It was also issued to the media and it illustrates our attitude to all motions put before the Council and to the situation in general.

This Council was elected democratically by the electors of Craigavon on May 15th 1985. Since that time we have failed to exercise our limited powers on behalf of the electorate while awaiting a lengthy legal process and decision. The judical ruling at the end of the case is juite clear and unambigious:"This Council would not have the potter to exclude ... had it sought to do so ... by exercise of its protective and self-defensive powers."

The Workers Party accept the judical decision. He believe that the rate payers money has been used extensively, if not perhaps misely, to establish the legal position. If this Council accepts the rule of law then we have a political obligation to proceed with the business we were elected to do.

NOrkers Party is one of the few parties in NI that has for many years, called for a Bill of Rights for III which would incorporate the European Convention. We have therefore no hesitation whatever, and indeed welcome, the notice of Motion Number 1 on the agenda. This motion, if passed by this Council, will mark a watershed in the history of Craigavon Council. This Council, by condemning those who seek to limit or destory the rights and freedoms of the European Convention, makes itself amenable and answerable to the Convention for all its oum actions and decisions. This has profound implications therefore for how we proceed with regard to such matters as the Fair Employment ... gency and Junday opening of recreational amenities: are we now saying that we will guarantee civil and religious liberty to all ratepayers and end the imposition of the moral views of some on all citizens? Je sincerely hope that this is the case.

### Notion 2:

The Workers Party has a long record of opposition to violence and terror and it has paid a heavy price for this. We welcome this opportunity to place on record our abhorrence at the violence perpetrated in this council borough last weekend. The perpetradors of that most wilful, promeditated and murderous violent activity against the law enforcement agencies were those who have so often shouted for rigorous Law and Order enforcement on a partisan basis in the past. There can be no such partisan support for Law Enforcement. Heither can there be partial denunciations of violence. The Norkers Party rejects and condemns all violence, regardless of the perpetrator or victin. This Council should demonstrate here tonight that it is not hypocritical in its condemnations of violence or partisan in its attitude to law enforcement. Notions 3+4;

In light of what we have earlier sail about the European Convention of Human Rights and the court action this Council engaged in, The Norhers Party regards resolutions 3+4 as a legal noncense. The Council has no power to exclude any of its elected members from its business. The proposers of these motions should come clean and tell us what they are really seeking to do: they want to further prevent this Council sitting down and dealing with its business and seek instead another costly, and probably fruitless legal battle in the courts.Councils in NI have limited enough powers in : any further procrastination and manoeuvering here could well lead to the suspension of this Council and its powers transferred to an undemocratically appointed Commissioner. Is that what we really want? in end to the limited democratic rights the people of Craigavon already have? le were not elected to spend the next four years fighting legal battles: se were elected to get on with the business of running the services provided by this Council for the benefit of all the electorate. We should stop evading that responsibility. The Workers Party does not believe it right or proper to leave our principal officers taking decisions without political direction. That is an abdication of responsibility and undemocratic. He ove to those people in our employment to provide the leadership and direction that is properly and lawfully iven to us, all elected members, under the Local Government let. Autions 3+4 are a nonsence and The Morkers Party will not be supporting them. Let us with the business we were elected to deal with.

### THE LOCAL ELECTIONS

Both in Northern Ireland and in the Republic, we performed very well. Victories are important to morale and particularly when we know our victories are based on hard work over a long period.

Our support is not based on emotion but on reasoned argument. We have a very solid base on which to build and we should communicate with this For example, in Leixlip, the branch, over the month of Aguust, base. began a canvass of electors, who committed their first preference vote in the Local Elections, for Irish People Sales. The success rate has been very encouraging. We must further educate our base in order for it to expand and propagate our ideology.

We must tell our supporters of our successes and ensure they are not seen as isolate victories. Our transfer rate between candidates, where we stood more than one, was unprecedented - over 90% in one case. We did not contest and lose any seat which we held prior to June. No other Party can say this. We expected all the seats we won. We narrowly missed seats in Navan, Athy, Cork City, Blanchardstown, Lucan and Belfast. Should we have had candidates, it is conceivable that we would have won seats in Gorey, Athlone, Mullingar, Castlebar, Letterkenny and Killarney to mention some areas. Our holding of Council seats went from 9 to 21. It is important, however, that these seats were won after years of hard work and that further victories will only be based on hard work and consistency.

### COUNCILLORS

It is important that we see our public representatives as delegates from the Party. The work load has to be shouldered by us all. Advice Centres must continue as Workers' Party Advice and Information Centres and be seen to be such. Business and strategy for Council meetings is a matter for the local branch, constituency or region, as the case may be. Everyone must feel part of the job and no elected representatives can be allowed to grow away from the Party.

Council seats must be used to build the Party. They are stepping stones to Parliamentary representation but only if the work is done. We don't have a majority on any council so we can't sit back and relax - remember, one councillor, two or three is only the beginning.

The pressure on Councillors is tremendous, and in particular on newly elected ones, so every effort must be made to ensure a back up team is available to help with Advice Cases, Publicity, Research etc..

## WATER TAX

Most Councillors have now tabled resolutions seeking the abolition of the tax and in some cases, an amnesty for defaulters. Fianna Fail in typical fashion, are trying to duck out of their 'commitment' given over the course of the Local Elections. The Water Tax issue became such because we made it so, now, it is crucial to keep the pressure on

## WATER TAX CONT'D./2

All the arguments we put forward over the last two years are still valid. Fianna Fail and Fine Gael will not scream about uncollected tax, youth employment levies, health charges etc. as they are all owed by their friends.

The situation should be monitored carefully and where you don't have Councillors or a Councillor raise the matter with your local media. Especially on Fianna Fail controlled Councils, their equivocation or aboutface should be exposed. It would be worthwhile to pick quotes from election speeches.

## FUNCTIONS OF CONSTITUENCIES

a) to co-ordinate branch activity in the constituency b) to extend Party membership in the area c) to establish and monitor new Party branches. d) a constituency council should convene a general members meeting within the constituency to nominate candidates for National and Local Government elections, subject to ratification by the Ard Comhairle/C.E.C. All members of good standing in the Cumainn/Branches within the constituency should be entitled to vote and receive notice of the convention in writing. e) to supervise and direct candidates/public representatives of the Party in the area.

f) to develop Party educational activity. to oversee fundraising and general finance of the Party in the area. **g**) to promote the sale and distribution of Party literature in the area h) through all appropriate channels. i) to hold public meetings to promote the Party in the area. to facilitate the involvement of non-members in constituency work for the Party and to maintain contact with them on a regular basis, through social activity, public meetings, fund raising etc. The Constituency Council may, where feasible, establish 'Constituency Associations' in its area.

k) to elect two delegates to the Regional Council. I) to ensure the registration of all members annually.

## NEW BRANCHES

While every encouragement is given to the formation of new branches, would Constituencies please notify the Executive Management Committee, at least two weeks in advance of their formation.

## CHAIRPERSONS & SECRETARIES

Fundamental tothe operation of any committee of the Party are efficiently run meetings. As most Regional, Constituency and branch committees are newly elected the following points, while not exhaustive, are for the benefit of Chairpersons and Secretaries.

## SECTION 31

Under Section 31 of the Health Act (1970), the Minister for Health can declare overspending by the Health Boards as illegal. Ar. Desmond has done just this and has informed the Health Boards that overspending on their budget will be illegal this year.

The South Eastern Health Board, for example, will run out of money by November and after that date it will be illegal for the Chief Executive to sign cheques. The budgets were handed down to the Health Boards by the Minister.

Cutbacks in the Health Services have been ongoing for the past number of years. However, there does not appear to be any genuine efforts being made to collect Health Charges outstanding or to question charges for services levied by private companies.

The following extract from a National Daily will throw some light on the position in the various Health Boards. The Health & Social Services Committee will be requested to draw up a plan of campaign on the cutbacks and you will be informed when details become available. Extract:

## YOUTH PARLIAMENT

Recently National Youth Organiser addressed a well attended meeting in Belfast of Youth group members from all over the city. Official recognition should also be extended to SWAPO as the representatives of the Namibian people. While international attention in recent months has been focussed on internal developments within South Africa, that country's illegal occupation of Namibia continues, and its security forces continue to wage a bloody war against the Namibian people.

Finally, if you have read these notes it is likely you are neither a Chairperson or Secretary, so if you are unhappy with the way your meetings are being run, raise the matter and quote 'Notes & Comments'! If you are however, a conscientious Chairperson or Secretary, take note that many hard won recruits drift away because of badly run meetings where no campaign work or education was discussed.

## AFFILIATION FEES

Branch Affiliation Fees are now due. The fee remains at £50.00 and every effort should be made to pay the full amount by the end of September. The fee for student branches is £20.00 per annum.

## Re-Registration

Members are required to re-register on May 1st each year. This is done by the Branch Secretary submitting; Fully Paid Up Cards for the Outgoing Year with £1. to Head Office. The right hand, inside page of your card should be completed. According to records these are a lot of members unregistered at the moment so Secretaries are instructed to call for Card checks at all meetings. In fact, all members are encouraged to request card checks at any Party meeting.

Section 10 of the Party's Constitution requires that all re-registration be completed within 3 months after the Ard Fheis i.e. by the end of July !

1. Notice of meetings should be properly communicated to all concerned. 2. Meetings should commence at the appointed time. 3. A prepared Agenda should be read to the meeting and agreed, and 4. The minutes should be kept in a hard backed book, be read and signed at 5. The administrative elements should be at every meeting and be dealt with quickly i.e. subscriptions, registration etc., reports from officers, 6. There should be an educational content at all meetings. 7. Development of the Party should be a regular item tabled for discussion and this should not be confined to the electoral arena. We need constituency associations, Youth & Women's groups etc.. How to spread the Party ideology in your locality requires discussion. 8. A commitment to work should be sought and ascertained from each member 10. A register of membership subscriptions, associate membership, accounts and minutes should be kept in a secure place by responsible personnel.

The Ard Comhairle(CEC) met on Friday o and Saturday 7 September. The main business of the meeting was to ellect the officer board , the Political and Management committees and the Chairpersons of the various specialists committes.

It was also reported that in, some streets the number of voters far exceeded the number of residents. While it is practice in some ar as to check the register between elections, this is not widespread.

Constituency Directors should now engage each branch in checking the register between now and Christmas. This can be done quietly but thoroughly. While you are creating votes Fianna Fail & Fine Gael are just putting names on the Register of Electors. It is likewise important to check your strong areas and ensure the sons and daughters of supporters are on the register. It appears that this practice of fictitious names on the register is growing especially since the introduction of new legislation to combat personation.


